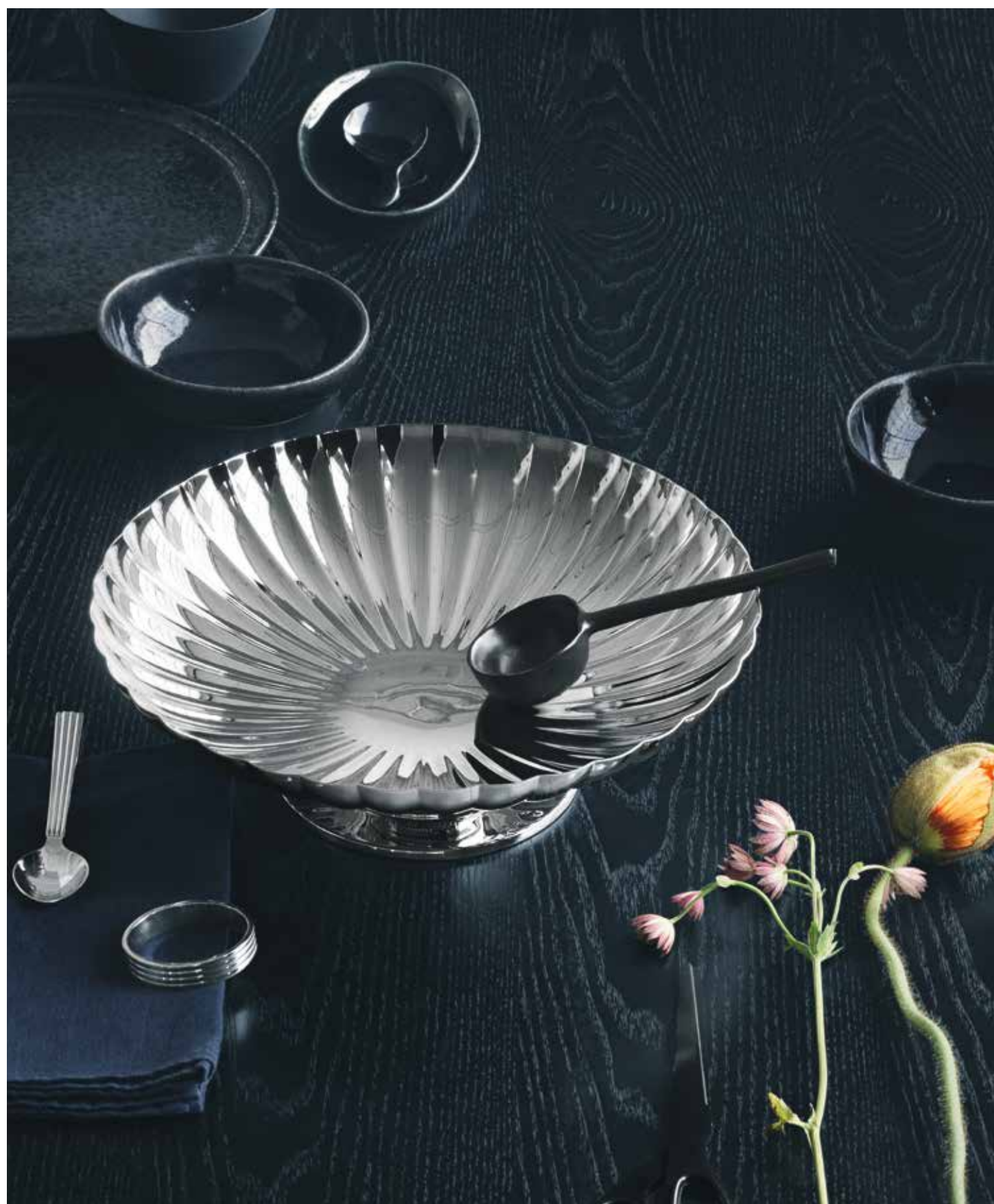

Prince Sigvard Bernadotte (1907-2002) was educated from the Royal Art Academy in Stockholm in 1929. He was influenced by the breakthrough of functionalism and the functional ideals of elegance are incorporated in his designs.

Prince Sigvard Bernadotte and Georg Jensen had a long and fruitful collaboration, with functionalism at the center of a modern interpretation of the silver smith craft. The Princes long connection to Georg Jensen represents a chapter of Scandinavian design history and the Bernadotte collection has been a favorite for generations, and still is.

The Bernadotte Dish on Stand continues the beloved contours of the legendary designer Sigvard Bernadotte. Inspired by Sigvard Bernadotte and designed by the Georg Jensen design team, the dish serves to complete the line of table decor in the Bernadotte collection by uniting design elements from early works by Bernadotte in one piece. Inspired by bowls from the Bernadotte collection, the gracefully curved surface rests on a base taken from original candlesticks. The Bernadotte dish is crafted in mirror polished stainless steel and it elegantly accompanies the existing works of Bernadotte, though it has a powerful aesthetic presence all on its own.

The Bernadotte Dish on Stand accentuates any table setting as it brings continuity to a timeless George Jensen classic.

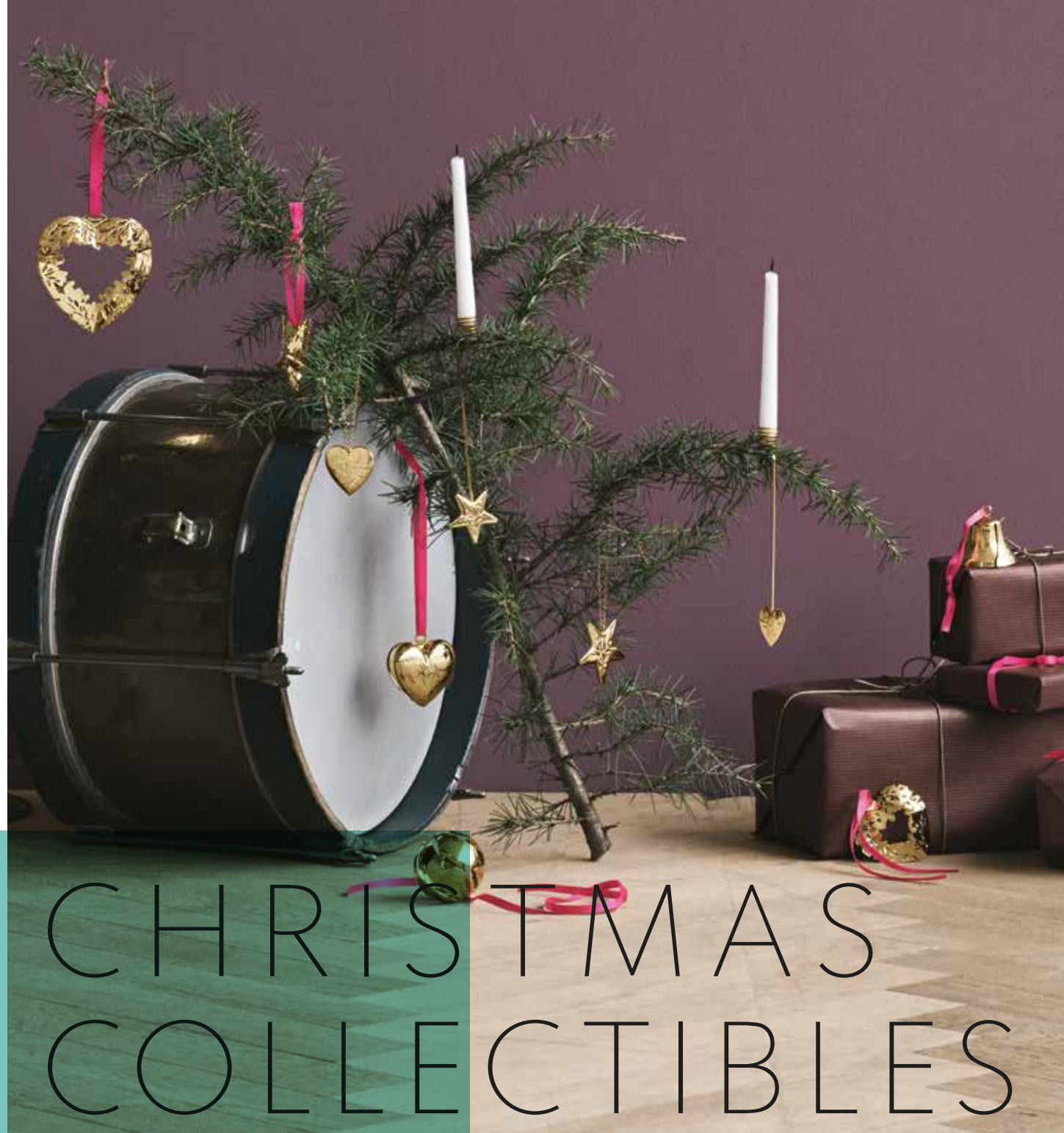

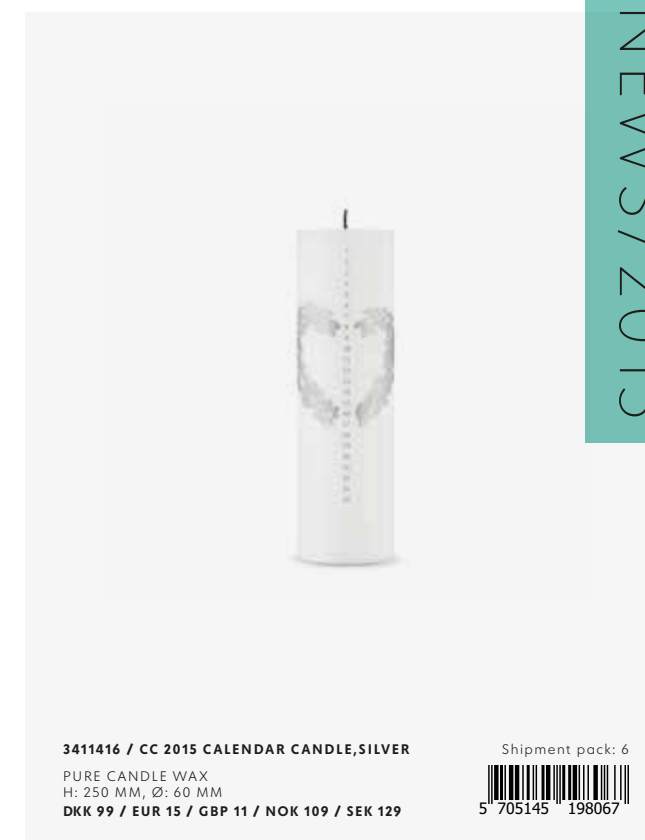
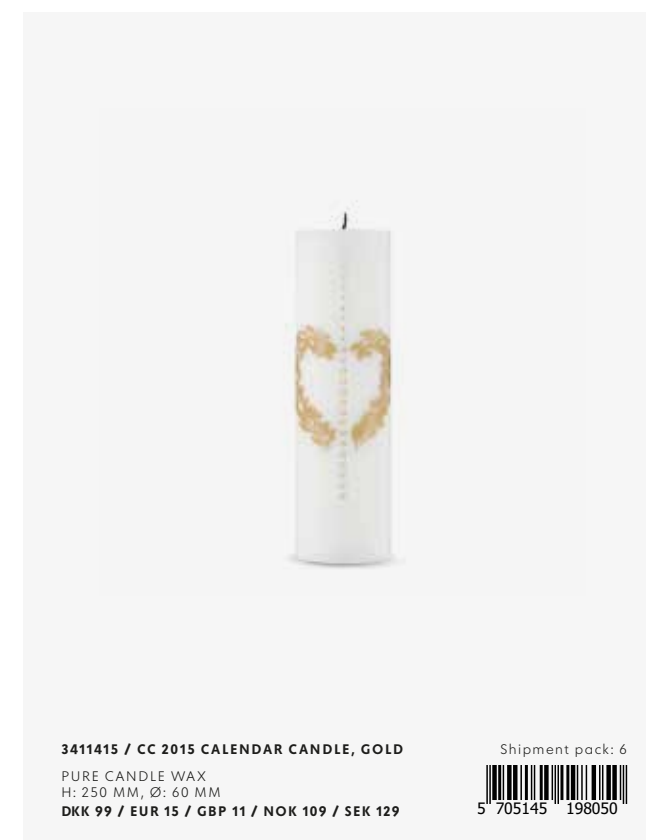

I tilfælde af uoverensstemmelse mellem Aftalen og de generelle samhandelsbetingelser, skal Aftalen have forrang. Definitioner anvendt i Aftalen og tilhørende bilag skal have samme betydning i de generelle samhandelsbetingelser.

Samhandelsbetingelserne udgør et selvstændigt Bilag 6 i aftalekomplekset og optrykkes sammen med prislisen, også benævnt Bilag 5, udelukkende for brugervenlighedens skyld.

1. BESTILLINGSBESTEMMELSER

- 1.1 Bestillingsbetingelser er angivet i Aftalens pkt. 12.1 -12.4.
- 1.2 Ændring eller annullering af ordre kan kun ske efter særskilt aftale med Georg Jensen. Ordre på varer, der specifikt produceres til Forhandleren, kan eksempelvis ikke ændres eller annulleres.

2. PRIS- OG BETALINGSBETINGELSER

- 2.1 Priser fremgår af den til enhver tid gældende prisliste vedlagt som Bilag 5. Der tages forbehold for eventuelle prisændringer, der varsles mindst én (1) måned forud for ændringernes ikrafttræden.
- 2.2 Alle varer faktureres til den på faktureringsdagen gældende nettopris. Alle fakturaer fremsendes elektronisk, dog vil det være muligt at få tilsendt faktura pr. brev mod et gebyr på DKK 15,00 pr. faktura.
- 2.3 Alle varer leveres i det i Bilag 5 oplyste antal pr. kolli. Ved brud på kolli, pålægges varerne i det brudte kolli 10 % af nettoprisen.
- 2.4 Faktura forfalder til betalingen 30 kalenderdage fra fakturadato. Ved betaling efter forfaldsdato, tillægges morarenter i henhold til gældende rentelov. Forhandlerens pligt til at betale rettidigt består, selvom Forhandleren reklamerer over fejl eller mangler.

3. LEVERING

- 3.1 Leveringstider oplyses efter Georg Jensens bedste skøn. Georg Jensen orienterer løbende Forhandleren, såfremt der måtte opstå yderligere forsinkelser end først antaget.
- 3.2 Ved hasteordre pålægges et gebyr på DKK 250,00. Hasteordrer er ordrer afgivet af Forhandleren til afsendelse fra lager samme dag eller næste dag. Hasteordre afsendes fra lager samme dag, hvis ordren er indtastet inden kl. 10.45 ellers den efterfølgende dag. Der tages dog forbehold for manglende varer på lager.
- 3.3 Levering af ordrer er med forbehold for forfalden saldo og overskredet kreditmaksimum hos Forhandleren.
- 3.4 For alle forsendelser i Danmark beregnes et fragtgebyr på DKK 50,00 uanset ordrens størrelse. Forhandleren kan anmode om, at ordren skal afsendes fra lager 2 dage efter bestilling er afgivet, eller om der i stedet skal ske levering på den ugentlige ordinære leveringsdag. Restordrevarer, som ikke kan afsendes med hovedordren, leveres fragtfrit.
- 3.5 Incoterms 2010 DAP finder anvendelse, medmindre andet er angivet i Bilag 1.
- 3.6 Forhandleren er forpligtet til at undersøge følgeseddel ved modtagelse af varerne og at informere Georg Jensen om evt. afvigelser i forhold til den fremsendte ordrebekræftelse senest 3 dage fra varernes modtagelse. Hvis den ydre indpakning af varerne er beskadiget ved leveringen, skal Forhandleren lave en anmærkning herom på kvitteringen for forsendelsen.

4. FORSIKRING

- 4.1 For alle varer tegner Georg Jensen en transportforsikring, der beregnes med 0,5 % af faktura-værdien. Brækage må holdes til forsikringselskabets disposition, indtil kreditnota foreligger.

5. EJENDOMSFORBEHOLD

- 5.1 Leverede varer forbliver Georg Jensens ejendom, indtil betaling for disse er registreret hos Georg Jensen.

6. TEKNISK SUPPORT

- 6.1 Georg Jensen yder Forhandleren teknisk support i form af produktreparationer og størrelsesændringer for relevante produkter. Priser herfor oplyses af Georg Jensens kundeservice ved forespørgsel.

7. REKLAMATION

- 7.1 Eventuelle reklamationer fra Forhandlerens side skal finde sted indenfor 7 arbejdsdage efter varens modtagelse ved henvendelse til Georg Jensens kundeservice.
- 7.2 Såfremt der er tale om skjulte fejl eller mangler, skal Forhandleren reklamere herover senest 7 arbejdsdage efter Forhandleren har konstateret den pågældende mangel eller fejl, dog senest 2 år fra leveringstidspunktet.
- 7.3 I tilfælde af berettiget reklamation har Georg Jensen efter eget valg mulighed for at ombytte varen eller at kreditere prisen, som Forhandleren har betalt for den pågældende vare. Forhandleren har ikke andre misligholdelsesbeføjelser.

8. RETURNERING

- 8.1 Forhandleren kan kun returnere Produkter, hvis der indgås særskilt aftale med Georg Jensen herom, og såfremt alle betingelser i pkt. 8.2 – 8.5 er opfyldt. Produkter, der returneres uden forudgående aftale med Georg Jensen, sendes tilbage til Forhandleren for Forhandlerens regning og risiko.
- 8.2 Alle returvarer skal ledsages af en returnota udstedt af Georg Jensen, som vil blive ophævet, hvis ikke varerne ankommer indenfor 30 kalenderdage fra datoen på returnotaen.
- 8.3 Returvarer skal indgå i det aktuelle produktsortiment hos Georg Jensen. Udgæede produkter kan ikke returneres, medmindre der indgås særskilt aftale med Georg Jensen herom.
- 8.4 Returvarer skal være uåbnede og ikke beskadigede samt pakket i original emballage uden prismærker, således at de kan tilbageleveres til Georg Jensens lager med henblik på et nyt salg fra Georg Jensen.
- 8.5 Returvarerne skal pakkes forsvarligt, således at de ikke beskadiges under transporten. Eventuel beskadigelse under transporten er Forhandlerens risiko. Krediteringer i forbindelse med returvarer fratrækkes 15 % til delvis dækning af håndteringsomkostninger ved behandlingen af returvarer.
- 8.6 Omkostningen til evt. fragt og transportforsikring via fremmed transport bæres af Forhandleren. Living og Seasonal returvarer sendes franko til:

9. VIDERESALG

- 9.1 Forhandleren må alene videresælge Georg Jensens produkter til forbrugere eller andre autoriserede Georg Jensen forhandlere under det selektive distributionssystem i overensstemmelse med Aftalens pkt. 5.3 - 5.4.

10.ÆNDRINGER OG MUNDTLIGE TILKENDEGIVELSER

- 10.1 Samhandelsbetingelserne revideres i overensstemmelse med Aftalens pkt. 26.4.
- 10.2Mundtlige tilkendegivelser er først bindende, når de skriftligt er bekræftet af Georg Jensen.

GENERAL TRADE TERMS AND CONDITIONS FOR AUTHORISED RETAILERS IN EUROPE

shall form an integrated part of the Authorised Retailer Agreement between Georg Jensen and the Authorised Retailer ("Agreement") together with the Appendices appended thereto. For the avoidance of doubt, where there is any conflict between these Trade Terms and Conditions and the Agreement, the terms of the Agreement shall prevail. Any defined terms used in these Trade Terms and Conditions shall have the meaning given to them in the Agreement or its Appendices save as otherwise provided herein.

These Trade Terms and Conditions form Appendix 6 to the Agreement and are published together with the pricelist, also referred to as Appendix 5, for ease-of-use reasons only.

1. ORDERING OF PRODUCTS

- 1.1 Products shall be ordered in accordance with clauses 12.1 -12.4 of the Agreement.
- 1.1 An order only can be changed or cancelled by the Authorised Retailer upon explicit agreement with Georg Jensen regarding this particular order. For instance, orders concerning goods, which are manufactured specifically for the Authorised Retailer, cannot be changed or annulled by the Authorised Retailer.

2. PRICES AND PAYMENT TERMS

- 2.1 The prices payable by the Authorised Retailer to Georg Jensen are as set out in the Price List enclosed as Appendix 5. The Price List is subject to amendments, provided that notice of such amendments will be given at least one (1) month prior to their entry into force.
- 2.2 All Products are invoiced at the price valid at the invoicing date. All invoices will be delivered electronically. It will however be possible to receive an invoice by post against a fee of EUR 2,00 per invoice.
- 2.3 All Products will be shipped containing the full box count per box as indicated in Appendix 5. If the Authorised Retailer chooses to order an amount of Products requiring breaking down a box, a surcharge of 10% of the net price will be levied on the product count in the broken down box.
- 2.4 Invoices are payable at 30 calendar days from the invoice date. Interest will be added to payments received after the due date in accordance with the current statutory rate at the time of such default in accordance with Danish Act on Interests. The Authorised Retailer's obligation to pay timely remains also in case of the Authorised Retailer's complaint regarding defects and deficiencies.
- 2.5 Authorised Retailer shall pay to Georg Jensen all sums when due, immediately and without reduction or deferment on account of any claim, counterclaim or set-off whatsoever.

3. DELIVERY

- 3.1 Delivery times are given as a best estimation by Georg Jensen. Georg Jensen will keep the Authorised Retailer continuously updated should there be greater delays than first anticipated.
- 3.2 Urgent orders have a handling charge of EUR 35.00. Urgent orders are orders placed by the Authorised Retailer for same or next day shipping from stock. Urgent orders are shipped from stock on the same day provided it has been keyed in by 11 a.m. CET or it will be shipped the following day, unless the order contains out of stock products.
- 3.3 Georg Jensen reserves the right to suspend delivery of Products for which an order confirmation has been sent but which have yet not been sent to the Authorised Retailer, if the order value exceeds the Authorised Retailer's agreed credits, or if the Authorised Retailer is in breach of payment for Products previously delivered.
- 3.4 A freight charge according to below will apply to all shipments, irrespective of the size of the order. Backorders, which do not ship with the main order, will be shipped f.o.c.

- 10.2 Oral declarations are binding only when confirmed in writing by Georg Jensen.

- 1.2 Ändring eller annullering av en beställning kan först ske efter överens-kommelse med Georg Jensen. Beställningar av produkter som tillverkas specifikt för återförsäljaren kan exempelvis inte ändras eller annulleras.

2. PRISSÄTTNINGS- OCH BETALNINGS-VILLKOR

- 2.1 Priserna framgår av den gällande prislistan som bifogas som Bilaga 5. Med förbehåll för eventuella prisändringar som meddelas minst en (1) månad innan de träder i kraft.
- 2.2 Alla varor faktureras till det på faktureringsdagen gällande nettopriset. Alla fakturor skickas elektroniskt, men det kommer att vara möjligt att ta emot fakturor per brev mot en avgift på 150 kronor per faktura.
- 2.3 Alla varor levereras i det i Bilaga 5 angivna antalet per paket. Vid bruten förpackning tillkommer 10 % på nettopriset på varorna i den brutna förpackningen.
- 2.4 Fakturan förfaller till betalning 30 kalenderdagar efter fakturadatum. Vid betalning efter förfallodagen utgår dröjsmålsränta enligt gällande räntelag. Återförsäljarens skyldighet att betala i tid kvarstår även om återförsäljaren reklamerar fel eller brister.

3. LEVERANS

- 3.1 Georg Jensen informerar om leveranstiderna efter att ha gjort en uppskattning. Georg Jensen informerar regelbundet återförsäljaren om det skulle uppstå ytterligare förseningar än väntat.
- 3.2 För expressbeställningar utgår en avgift på 250 kronor. En expressbeställ-ning är en beställning som ska skickas från lagret samma dag eller nästa dag. Expressbeställningar levereras från lagret samma dag om beställ-ningen läggs senast kl. 10:45, annars nästa dag. Hänsyn tas dock till om varorna finns i lager eller inte.
- 3.3 Leverans av beställningar är med förbehåll för förfallna fakturor och överskriden kreditgräns hos återförsäljaren.
- 3.4 För alla transporter i Sverige beräknas en fraktavgift på 145 kronor oavsett orderstorlek. Återförsäljaren kan begära att ordern skickas från lager två dagar efter beställning, eller om leveransen i stället ska ske på den ordinarie veckovisa leveransdagen. Restnoterade varor som inte kan levereras med huvudbeställningen levereras fraktfritt.
- 3.5 Incoterms 2010 DAP ska gälla om inte annat anges i Bilaga 1.
- 3.6 Återförsäljaren är skyldig att undersöka följesedeln vid mottagandet av varorna och informera Georg Jensen om eventuella avvikelser i förhållande till orderbekräftelsen inom senast tre dagar från mottagandet av varorna. Om ytterförpackningen är skadad vid leveransen ska återförsäljaren skriva en anteckning om det på kviteringen.

4. FÖRSÄKRING

- 4.1 Georg Jensen tecknar en transportförsäkring för alla produkter som beräknas till 0,5 % av fakturavärdet. Skadade varor ska vara till försäkringsbolagets förfogande tills en kreditnota har utfärdats.

5. ÄGANDERÄTTSFÖRBEHÅLL

- 5.1 Levererade varor förblir Georg Jensens egendom tills betalning för dem har registrerats hos Georg Jensen.

6. TEKNISKT STÖD

- 6.1 Georg Jensen erbjuder återförsäljaren tekniskt stöd i form av produkt-reparationer och storleksändringar för relevanta produkter. Kostnaden för detta lämnas av Georg Jensen kundservice på begäran.

7. REKLAMATION

- 7.1 Eventuella reklamationer från återförsäljaren ska göras till Georg Jensens kundtjänst inom sju arbetsdagar efter mottagandet av varorna.
- 7.2 Om det rör sig om dolda fel har ska återförsäljaren reklamera dessa inom senast sju arbetsdagar efter att ha identifierat bristen eller felet, men inte senare än två år efter leveransen.
- 7.3 Vid ett berättigat klagomål har Georg Jensen möjlighet att efter eget val byta varan eller kreditera återförsäljarens kostnad för den aktuella produkten. Återförsäljaren har inga andra befogenheter vid avtalsbrott.

8. RETURER

- 8.1 Återförsäljaren kan bara returnera produkter om ett separat avtal om detta tecknas med Georg Jensen och om alla villkor i punkt 8.2–8.5 är uppfyllda. Produkter som returneras utan föregående avtal med Georg Jensen kommer att skickas tillbaka till Återförsäljaren på dennes bekostnad och risk.
- 8.2 Alla returvaror ska sändas med en retursedel utställd av Georg Jensen, som annulleras om varorna inte ankommer inom 30 kalenderdagar från datumet på retursedeln.
- 8.3 Returvaror ska ingå i Georg Jensens aktuella produktsortiment. Utgående produkter kan inte returneras om inte ett separat avtal om detta tecknas med Georg Jensen.
- 8.4 Returvarorna ska vara öppnade och oskadda samt paketerade i originalemballage utan prismärkning så att de kan återsändas till Georg Jensens lager och därefter säljas på nytt av Georg Jensen.
- 8.5 Returvarorna ska packas omsorgsfullt så att de inte skadas under transporten. Eventuella skador under transporten är återförsäljarens ansvar. Vid kreditering i samband med returvaror dras 15 % av för att delvis täcka hanteringskostnaderna för behandling av returvaror.
- 8.6 Återförsäljaren ska stå för kostnaden för en ev. frakt- och transport-försäkring via en utländsk transportör.

- 8.7 Living- och Seasonal-returvaror skickas fullt frankerat till:

9. ÅTERFÖRSÄLJNING

- 9.1 Återförsäljaren får endast sälja Georg Jensens produkter till konsumenter eller andra behöriga Georg Jensen-återförsäljare i enlighet med det selektiva distributionssystemet som anges i punkt 5.3–5.4 i avtalet.

10. ÄNDRINGAR OCH MUNTliga MEDDELANDEN

- 10.1 Handelsvillkoren revideras i enlighet med punkt 26.4 i avtalet.
- 10.2 Muntliga uttalanden är inte bindande förrän de bekräftas skriftligen av Georg Jensen.
